
In pursuance of the Plagiarism Prevention Policy of University of Kashmir notified vide Notification No. F(Adoption-PPP)Acad/KU/17 dated 20-06-2017, it is notified for information of all the "Research Scholars" of various Departments/Directorates/Institutes/Centres/Campuses of University of Kashmir who write their research theses/dissertations in languages other than English that the theses/dissertations should be now onwards written in their respective UNICODE compliant fonts and the softcopy of the final Ph.D./M.Phil. thesis/dissertation be submitted in MS-Word /PDF format on a CD duly signed by the scholar and the Supervisor(s) and forwarded by the concerned Head/ Director to the Nodal Officer/ University Librarian, Allama Iqbal Library for ascertaining the similarity index (S.I) using the available Anti-plagiarism software(s). The examples of some of the commonly used UNICODE complaint fonts which is not an exhaustive list are as follows:

The softcopy of the thesis/dissertation to be submitted for ascertaining S.I shall include a page wherein the title of the research work, name of the scholar and the supervisor should be written in English language (Romanized) and may exclude the preliminary pages including certificate(s), declaration, dedication, acknowledgements and list of references/bibliographies.

Further, as per the notified Plagiarism Prevention Policy, only two submissions are allowed for each scholar for his/her thesis/dissertation and the department must maintain a record for each submission.
